In such cases the undersigned company will be subject to the application of the Arbitration Regulations of the Commodity Exchange of Bologna/A.G.E.R. in all its parts, including the envisaged automatic procedure.

The undersigned also hereby states that it is familiar with the General Conditions and the standard contracts of the Associazione Granaria Emiliana Romagnola, that it is fully familiar with their contents, and that it is familiar with and accepts, in particular, the Arbitration Clause for Informal Arbitration contained in the Particular Conditions of the standard A.G.E.R. contracts, and hereby agrees to comply with all the aforesaid provisions and agreements, as well as with the Internal Regulations of the Commodity Exchange of Bologna.
